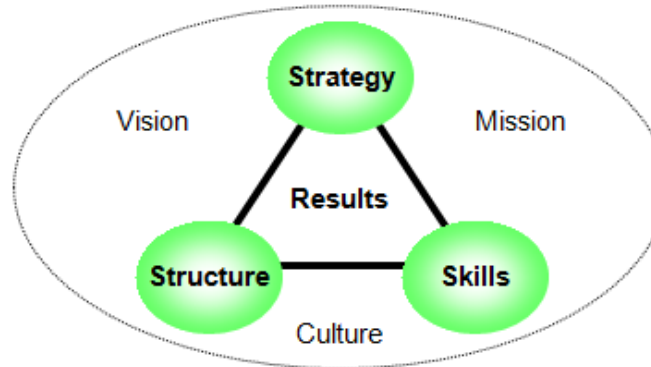

CONCEPT

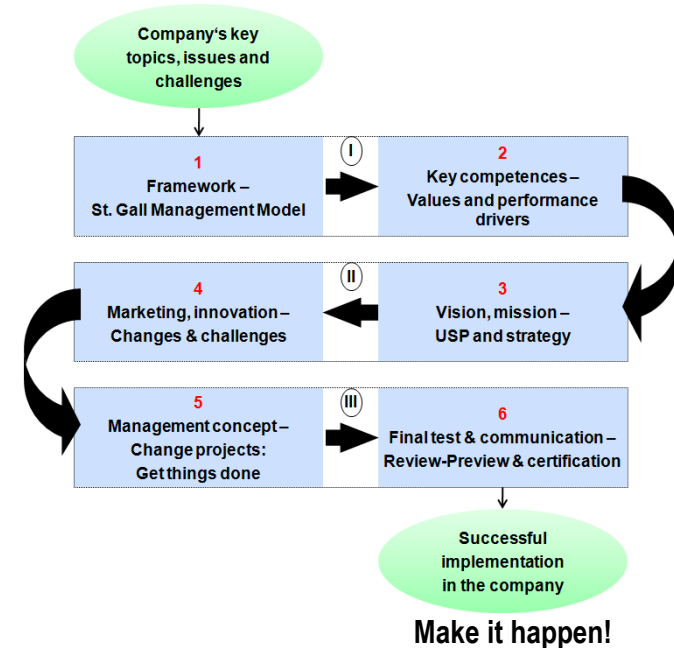

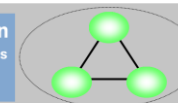
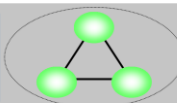
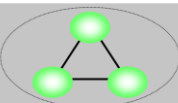
PROGRAM AND CONTENT.
