Conference regulations

"Economic Outlook 2025"

§ 1 General information and definitions

- 1. The organizer of the conference is the Polish-Swiss Chamber of Commerce, with headquarters at Al. Niepodległości 18, 02-653 Warsaw, NIP: 526-23-22-109 together with Advantage Austria Warsaw, Austrian Embassy Commercial Department, ul. Królewska 16, 00-103 Warsaw.
- 2. The partners of the Conference are:

- 3. Organizer an entity responsible for all organizational activities related to the Conference, collecting and processing personal data, image, voice and materials provided by Conference Participants and Speakers.
- 4. Partners entities supporting the Organizer in organizational activities, especially in promoting the Conference and in preparing the content of the Conference, processing personal data of Participants and Speakers, as well as the image and voice of the above, recorded in the Conference recordings, to the extent described in these Regulations.
- 5. Conference An event organized by the Polish-Swiss Chamber of Commerce and Advantage Austria Warsaw with the member companies listed in point 1 a-c, which will be held on December 4, 2024, at 18.00 at the mBank Tower, Prosta 18, Warszawa
- 6. Regulations these Conference regulations.
- 7. GDPR Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC. Official Journal of the EU L. 2016 No. 119/1.
- 8. Participant An invited guest, a natural person over 18 years of age and having full legal capacity, a legal person and organizational units without legal personality, but able to acquire rights and incur obligations on their own behalf, which have correctly registered for the

Conference.

9. Speaker - Participant actively participating in the Conference.

§ 2 General provisions

- 1. The agenda of the Conference is available at swisschamber.pl.
- 2. The condition for participation in the Conference is registration of participation in the Conference via the application form, the link to which will be sent to the Participant via email and which will be available on the websites of the Organizers.
- 3. The Organizer reserves the right to change the Speakers or the program for reasons beyond his control.
- 4. Participation in the Conference is free of charge.

§ 3 Personal data and image

- 1. The Organizer is the administrator of the personal data of Participants and Speakers.
- 2. The Organizer reserves the right to transfer the personal data of Participants and Speakers, as well as recordings containing the image and voice of the Speakers, to the Conference Partners listed in §1 point a c, for organizational and promotional purposes of the event, in particular for the purposes listed in § 4 point 3.
- 3. Personal data of the Participant and the Speaker, provided during registration for the Conference and obtained during the conference, will be processed for the purpose of:
- a) organize and conduct the Conference in accordance with the provisions of the Regulations, including in particular: creating a list of Participants, sending information on the conference agenda and other organizational information, ensuring the possibility of asking questions during the conference
- b) recording the course of the conference in the form of a recording, which may be associated with the recording of the image and voice of the conference participant
- c) sending via electronic means of communication, i.e. e-mail, information (including commercial information) regarding the Organiser's products and services, in particular presented during the Conference, as well as information about subsequent editions of the conference
- d) investigation and defense against possible claims

- 4. By registering, the Participant and the Speaker consent to the processing of personal data and the use of the image recorded during the conference for the purposes specified in point 3 points a, b and c and in point 4.
- 5. Providing personal data is voluntary, but it is a condition of participation in the Conference in accordance with the formula in which it is organized. Conference participants have the right to access their personal data and the right to rectify, delete, limit processing, the right to transfer data, the right to object, the right to withdraw consent at any time without affecting the lawfulness of the processing, which was made on the basis of consent before its withdrawal.
- 6. All the above rights can be exercised by sending a written request by e-mail to the address swisschamber@swisschamber.pl
- 7. The personal data of the Participant and the Speaker will not be processed in an automated manner, they will also not be profiled.
- 8. The organizer takes all appropriate security measures in accordance with the law and generally accepted principles to protect the confidentiality of information. Information, including personal data, is secured adequately to the level of risk they generate.

§ 4 Intellectual Property Rights

- 1. The speaker declares that:
- a. Has intellectual property rights, including the right to make the content presented during the Conference available (hereinafter referred to as materials).
- b. The materials do not infringe anyone's rights or are in conflict with the law and morality.
- c. Allows the Organizer to record and further distribute the Materials according to recognition of the Organizer in particular by free transfer of audio, video and photo files to conference participants.
- d. Undertakes not to disclose information about the Participants, unless the Organizer allows it.
- 2. Any different arrangements regarding the scope covered by the above paragraph must be agreed with the Organizer in writing.
- 3. The above provisions also apply to the recording and dissemination of the image.

§ 5 Final provisions

- The organizer reserves the right to use the e-mail address provided during registration for the Conference in order to inform about changes to the online Conference program or its Regulations.
- 2. By registering for the Online Conference Participant confirms reviewing and accepting the Regulations.
- 3. During the Conference, the participant must follow possible guidelines of the Organizer.
- 4. The organizer reserves the right to change the Regulations.
- 5. The Organizer reserves the right in the event of any independent occurrence to change the agenda or change the date of the Online Conference.
